The Company

Forward Water Technologies is an independent company that is dedicated to the large-scale implementation of its proprietary forward osmosis technology. Soon to be listed on the TSX-V, the company is commercializing its core water purification technology in a number of industrial sectors.

The global pressure to maintain and enhance supplies of clean water is increasing. Forward Water's technology can simultaneously reduce the high volumes of challenging wastewater streams that have extraordinarily high levels of dissolved salts and return the clean water for re-use or release. In addition, the entire process is driven using relatively low energy inputs.

Our innovative water treatment technology allows manufacturing operations to clean their wastewater that would otherwise require costly disposal. The technology allows reclamation of up to 90% of the waste as clean water and return this valuable resource to the environment. Alternatively, the clean water can be reused by manufacturing operations to reduce their overall water consumption and environmental footprint. Currently, Forward Water is constructing its first field unit for pre-commercial trials.

The Opportunity

We are looking for independent directors to join our Board. Help set the goals and direction of a growing public company that is changing the way industry handles its wastewater.

In general, prospective directors should have an interest in serving on an early-stage public company Board that is commercializing a new wastewater treatment technology. Familiarity with the water sector would be an asset but is not required.
